Notice Inviting Expression of Interest

Objectives of the Scheme:-

1. The objective of the scheme is to promote availability of safe and conveniently located accommodation for working women, with day care facility for their children.

Location:-

Urban/Semi urban or even in rural areas where employment opportunity for women exist.

Roles of Private entity and WCD:-

1. Working Women Hostel shall be constructed on Public Land only. Land will be provided by the Department
2. 50% of the total construction cost shall be provided by Ministry. One time non-recurring grant at the rate of Rs. 7500/- per inmate at the time of commencement of the hostels for purchase of furniture and furnishings.
3. Private Entity shall bear 50% of the total cost of the construction and develop, design, provide infrastructure, operate, maintain and manage.

Last date for submission of Expression of Interest is **26.07.2016 upto 5.00 P.M.** Sealed envelope earmarked to the Director, Women and Child Development Department, Haryana, Bays No.15-20, Sector-4, Panchkula.

Bidding Process

Department of Women and Child Development, Haryana invites expression of interest from Public/Private Entity which may be a State Government agencies including Women Development Corporations, Women Finance Corporations etc. ,Urban Municipal Bodies including Cantonment Boards, Panchayati Raj Institutions , SHGs (Self Help Groups) ,Recognized Colleges/ Universities , Civil Society Organisations having proven track record of working in the field of women's welfare/social welfare and women's education subject to the condition that the organisation is registered under Haryana Societies Registration Act, 2012, Corporate or associations like CII, ASSOCHAM, FICCI etc.

Applicants are required to submit necessary documents/certificates in support of eligibility criteria as mentioned in the scheme guidelines which can be downloaded from www.wcd.nic.in

QUALIFYING CRITERIA

Any organization that wishes to apply should be:-

- a. Organization should be financially secure. Assessment of Financial Capability will be based on provision of 3 years turnover of Organization. The Turn over should be at least Rs. 10 Lakhs per year.
- b. Should not be blacklisted anywhere in India & no court case should be against the organization.
- c. Must provide the following information:-
 - i. Introduction to the Organization
 - ii. Correspondence Address, email address contact number.
 - iii. Organization is registered under which Act and registration certificate.
 - iv. Brief report of activity of the last three years.
 - v. Summary of audited accounts of since three years.
 - vi. Details of office of Organization and list of all regular employees with their educational details and salary.
 - vii. Details of Experience
 - viii. Self Attested Affidavit about (i) not black listed, (ii) no Court cases (iii) agree with the objectives & out puts set by the Union Government for both the schemes.
