In reference to the Request For Proposals(RFP) published in the newspapers (Dainik Bhaskar and Tribune) on 4th July, 2018 for calling the organizations for Empanelment of Skill Training Partners for Skilling Children of Child Care Institutions (CCIs) in Haryana. Following queries were raised by different organizations:-

Sr. No.	Queries	Decision Taken
1	<p>It is mentioned in the tender that ten years old company in skill development training and have been working with various departments like NSDC, Ministry of minorities, WDC Bihar Jeevika Skills Bihar, Hartron, UKSDM, SUDA, MANAS, NULM, PMKVY, STAR etc and have trained and placed more than 25000 candidates.</p> <p>We would like to draw attention towards the clause in the eligibility of Rs. 10 crores average turnover in last three years and Rs. 10 crores net worth in last year. The order value expected in the case is expected to be around Rs. 1 crore if the complete order is given to one company. The turn over should be atleast be Rs. 1 crore and more weightage should be given past experience. This is standard practice in all tenders of Government.</p> <p>It is requested to modify the clause of turnover to Rs 1to 2 crore and Net worth clause to Rs. 75 Lacs to 1 crore for fair participation.</p>	No Change

2	It is mentioned in the tender that the partner will be required to impart skill training to 1050 children only. Then why a bidder should have a turnover of Rs. 10 cr? We, DAV ITC is into the business of imparting skill development training from 14 years and have trained and placed more than 15,000 children and being a MSME and NSIC unit we would like to participate in this tender., in our opinion that average turnover should not exceed more than I cr. for 1050 children to be trained. Hence, it is requested to kindly consider the request for reducing the turnover to Rs. 1 crore as it is most suitable figure for the quantity mentioned in the tender.	No Change
3.	On the above mentioned point, it is mentioned that bidder should have average turnover of Rs. 10 crore in past three years and this point contradicts the statement. But how the department has arrived on this figure of Rs.10 crore for 1050 children needs to be trained.	No Change
4.	Does the authority wish to nullify the efforts made by bidder like DAV-ITC who is a renowned name in skill sector of imparting raining on PAN India basis including Haryana.	No Change
